





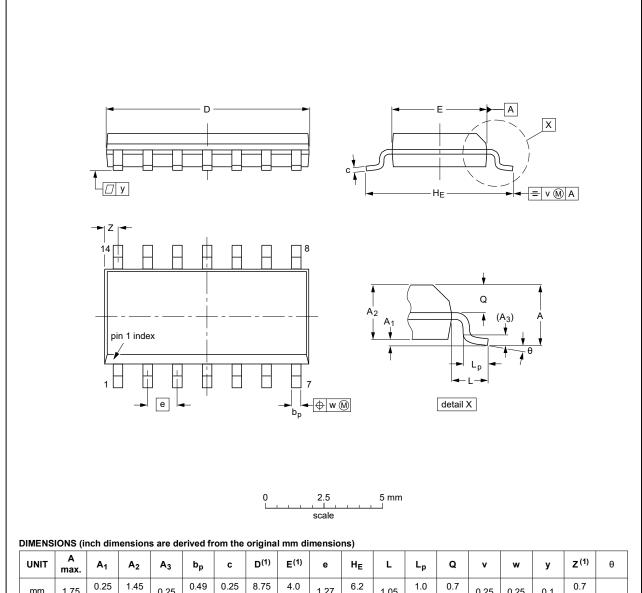

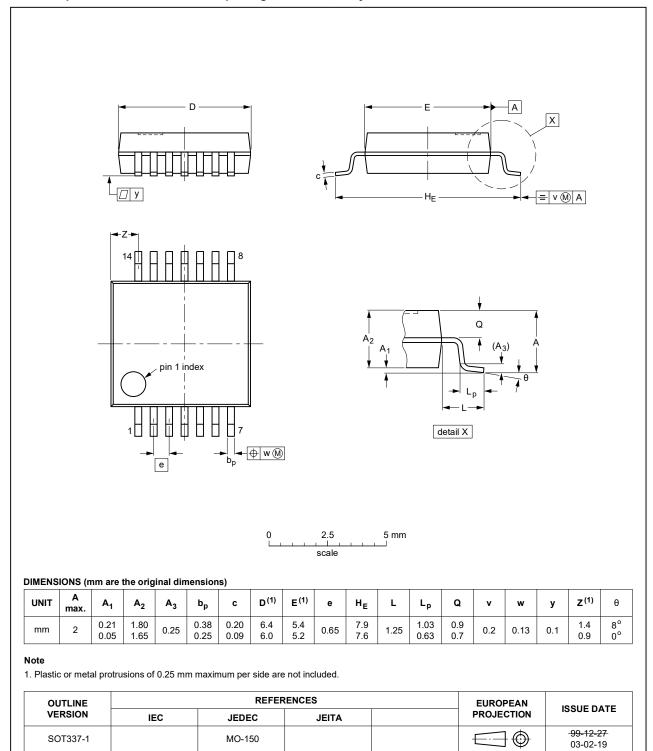
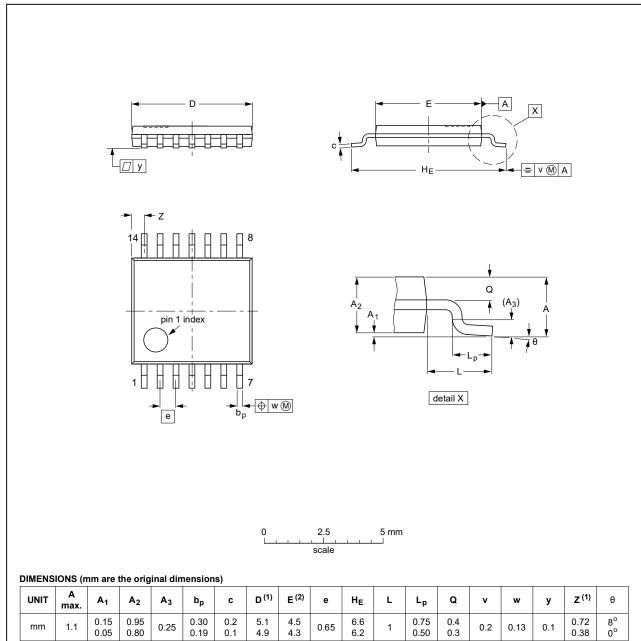


Fig. 9. Package outline SOT337-1 (SSOP14)
